(NOTICE FOR THE ELECTION OF GENERAL COMMITTEE MEMBERS)

The Members of the Association,

(Through the Convener, Primary Unit)

Dear Friends,

I am to inform you that under Rule XI(ii), your constituency is entitled to have _____ representatives on the General Committee of the Association **for the years 2017-2019** and I invite you to elect the said number of representatives and send the names to this office by **16th July, 2018.**

The election meeting will be convened by the Convener, Primary Unit, under Sec.VIII(d) of the Rules and Regulations of our Association. If, however, he is absent or unable to convene the meeting, the meeting may be convened by outgoing members of the General Committee from the Unit vide the by-Law (2).

In case, there is no Primary Unit in the College due to less than five members, one member will be elected to the General Committee from amongst themselves. Such meeting to elect the member of the General Committee will be Convened by the Senior most member of the Association of the College in consultation with the Secretary, District Committee.

Your attention is invited to clause (c) of Rule XXI, clause (c) of Rule XX and clause (b) of Rule XXI as quoted below:

XXI(c) “The names of the elected representatives shall reach the office of the Association together with the minutes of the meeting held for the election, by such date as may be specified by the General Secretary.

Provided that only those members whose subscriptions (for the year previous to that for which the election is being held) are not in arrear on the date of the meeting, and all new members duly admitted in accordance with Rule XX(a) shall be eligible to participate in the voting and to be returned as a General Committee Member.”

XX(c)..... “All disputes regarding election(s) shall be sent to the General Secretary within 10 days of the election(s) and decisions thereon shall be taken by the Election Board whose decisions shall be binding on all concerned. No complaint after the date referred hereto before shall be entertained.”

XXI(b)..... “Election of the ordinary members of the General Committee shall be held on the basis of the system of proportional Representation with single transferable vote on and from 1982.”

The names of the candidates with votes polled by each of them (indicating preferences) should also be sent to the office of the Association

• **Page4..... Administration.....One paragraph to be added.....**

To form a Primary Unit there must be at least five members in the respective College/University. In case a College/University has less than five members, the Election Board shall take necessary steps so that one member from such College/University is elected to the General Committee.
